Dear Sir/ Madam,

I have to inform you that under Section 3(3)(c) of the Architects Act, 1972, five persons are elected from among themselves by Heads of Architectural Institutions in India imparting full time instructions for recognized qualifications as members of the Council of Architecture.

In this regard, the Council had issued a Circular letter dated September 01, 2022 to all Heads of Institutions to confirm the details of their respective Heads of Institutions in an online form namely, “**Confirm Head of Institution**”, available at the login accounts of the institution at web portal of the Council, www.coa.gov.in, latest by 08.09.2022. However, till date no confirmation has been submitted by your institution.

In view of the above, the institution is once again requested to confirm the details of the Head of Institution in the online form latest by 14.09.2022 (**11:59 pm**) so that the same could be compiled and furnished to the Central Government for conduct of elections.

It may kindly be noted that this is the final reminder and no request for change/update of Head after the said date would be entertained by this office for the purposes of conduct of elections by the Central Government.


